A DESCRIPTION OF PHASE 5 TOWNHOUSE (TH-5) NEWTOWN GRANT (AKA) GOLDEN ACRES

- Thence continuing along the same S 64° 14' 00" W, 674.73 feet to a point, a common comer of this and the lands of N/L Robert A. and Elizabeth J. Hentz, crossing over a common corner of Phase SF-2 and Phase SF-1 257.83 feet from the terminus of this line;

- Thence along Phase I -Apartment/Condominium N 68° 14' 06" E 335.46 feet to a point crossing over a common corner of Phase I Apartment/Condominium and Phase TH-3B 98.15 feet from the terminus of this line:
- Thence along Phase TH-3B the following eleven (11) courses and distances to wit:

 - ° (2) N 20° 53' 18" W 40.73 feet to a point;

 - (10) N 57° 49' 42" E 96.00 feet to a point;
 - (11) N 48° 19' 17" E 89.07 feet to a point, a common corner of Phase TH-3B and Future Phase 4-TH;

- Thence along Future Phase 4-TH the following five (5) courses and distances to wit:
 - ° (1) S 52° 19′ 30″ E 313.39 feet to a point;
 - ° (2) S 32° 44′ 22" W 5.55 feet to a point;
 - ° (3) S 57° 15′ 38″ E 260.36 feet to a point;
 - ° (4) S 67° 19' 57" E 165.52 feet to a point;
 - (5) S 87° 11' 50" E 202.02 feet to a point along aforementioned westerly right of way of North Drive;
- Thence along said westerly right-of-way of North Drive along a curve to the left having a radius of 976.00 feet, an arc distance of 199.46 feet and a chord bearing and distance of S 01° 39' 00" W, 199.11 feet to a proposed concrete monument, a common point of said westerly right-of-way of North Drive and aforementioned southerly right-of-way of Honey Locust Lane, crossing over the terminus of said Honey Locust Lane to the first mentioned point and place of beginning.
